• Bishop's Ranch By-Laws revision — by necessity Bishop's Ranch is increasingly relying on non-Episcopal groups for business. They have no intention to cease being an Episcopal entity and have reaffirmed their desire for a chaplain funded from the



Bishop's discretionary fund. They want to maintain a spiritual base from the Episcopal tradition. There are currently 19 elected + 2 appointed members on the BR Board. Bylaws currently require the majority of the Board (13) be Episcopalians who are canonically resident clergy and baptized Episcopalians from Diocal. They are requesting a change of bylaws to reduce that number from 13 to 10, which is more than Canons require. Motion to approve bylaw amendment as proposed by Bishop's Ranch Board of Directors.

- Discussion about sale of St. John's to Clayton Valley Community Church which some members of the Executive Council are concerned is not a LGBTIQ+ affirming Church. At their July meeting Sc voted to leave the decision left to local congregation Holy Spirit Church. There is no evidence on their website that Clayton Congregational Church is anti LGBTQI+. This prompted a discussion about guidelines for congregations and other episcopal organizations leasing their space to other organizations which the recent Kairos revelation spotlight. SC suggested to the Bishop that it would be helpful if there was guidance for this, which would help congregations working with interfaith groups that may not have exactly the same values held by the Episcopal Church.
- Discussion on ordination process. Idea raised about joint discernment day for the COM, Bishop, & SC.
- General discussion on diocesan affairs.
- Bishop leaves for Abu Dhabi on 10/4.
- Cn. Christopher Hayes reminded SC that applicable Canons require congregations to be current with assessments in the 12 months previous to convention. If they are not, their delegation can be reduced proportionally. There are a number of churches seriously behind in their assessments and some less behind. The Secretary oof Convention is reaching out to these congregations individually. SC agreed it is important to maintain integrity of process to avoid situations like FL. SC agreed that the same standard should be applied to Diocesan convention in October and not only the Special Electing convention in December.

Diocese of California Committee on Nominations Report

The Committee on Nominations met on September 7, 2023, at 4:00 p.m. (PDT) via Zoom. In attendance: Stephen Siptroth, Jane Stratford, Don Miller, Sr. Dana Kramer-Rolls, William Burrell, Carolyn George, Patrick Anderson. The following is a copy of the notes from that meeting prepared by Patrick Anderson

- 1. Opening prayer offered by Jane at 4:03p.m.
- 2. Consider next steps related to verifying nominees' training completion. Stephen says we have nominees for each office. Next step is to confirm completion of required trainings. Should we send a list to Caren or Amy? Probably so. The status of some of the training lessons seems to be up in the air. Jane says there is later going to be a requirement for fingerprinting for Safe Church. Some discussion whether it is our responsibility to follow up to ask if they have completed the trainings. Someone suggested the nominees should accept some responsibility. Stephen will contact Caren and Amy to ask if the diocese is tracking this information.
- 3. Review and approve the chair's report to the Convention. Carolyn asks if it should say the EC and SC should nominate and recommend candidates. Don says if those bodies recommend candidates, other people will refrain from running against them. Jane says certain skill sets are needed, which is why some EC and SC members want to nominate people with those skills.
- 4. Consider outreach to deanery presidents ahead of fall deanery elections. Jane asks, do we really need two representatives from each deanery? Should we propose a change to the constitution? Clergy are already in short supply, and fewer lay people are stepping forward. It is understandable that we have reps from the EC and SC on this committee, but what do we expect from them? No answer needed now, but we should ask next year's folks to contemplate that.
- 5. Set next meeting date and time? No more meetings are needed before the convention. There is a unanimous Woo Hoo!
- 6. Closing prayer: Sr. Dana offers prayer at 4:56pm.
