### 7:05 PM ORIENTATION

- 1. Role & Responsibilities of Standing Committee Mauricio outlined the roles and responsibilities of the SC. Primarily SC is a council of advice and don't have the authority to tell the bishop what to do:
  - when there is a bishop in place, SC functions as a counsel of advice to the bishop. When there is no bishop, they are the ecclesiastical authority of the diocese, as laid forth in the national constitution and canons.
  - SC is responsible for overseeing the committee on governance and for certifying delegates to convention if the bishop is not available.
  - SC is involved in approving candidates for ordination and file reviews for ordination to the diaconate and priesthood. They are asked to be present at ordinations as part of the presenting group.
  - *SC* consent to election of bishops by national canon.
  - SC are charged with the deconsecration of church properties and are also involved in the renunciation of holy orders.

### 2. Role of Officers:

Officers are elected according to diocesan canons –
 President/VP/secretary. They set the agenda and meet with the
 bishop. to ascertain his needs for agenda. Officers do not have any
 authority in themselves, only as part of the body.

### 4. Committee Liaisons & Assignments
